RC BUSH PILOTS FIELD RULES Revision V3 3-2023

- 1. ALL PILOTS MUST BE A CURRENT MEMBER OF THE AMA, PASS THE RECREATIONAL UAS SAFETY TEST (TRUST), AND REGISTER THEIR AIRCRAFT WITH THE FAA TO FLY AT THIS SITE.
- 2. AMA CARD MUST BE DISPLAYED BY THE PILOT OR AT LEAST IN POSSESSION ON THEIR PERSON. ALL AIRCRAFT WILL BE MARKED ON THE OUTSIDE WITH AMA MEMBER NUMBER & FAA REGISTRATION NUMBERS. PILOTS MUST HAVE IN THEIR POSSESION PROOF OF TRUST PASSAGE & PROOF OF AIRCRAFT REGISTRATION.
- 3. ONLY AMA PILOTS, ASSISTANTS AND ESCORTED NON-MEMBERS ARE PERMITTED IN THE PITS AREAS. ALL CHILDREN UNDER THE AGE OF 12 MUST BE UNDER ADULT SUPERVISION.
- 4. NO TAXIING WITHIN THE PITS AREAS.
- 5. SPECTATOR AREAS AND PICNIC TABLES ARE NOT TO BE USED AS AN AIRCRAFT PIT BENCH.
- 6. ANNOUNCE YOUR INTENTIONS LOUDLY TO MAKE OTHER PILOTS AWARE OF YOUR ACTIONS. ANNOUNCE HIGH-SPEED PASSES, TAKEOFFS, LANDINGS, CROSSING THE RUNWAY AND ALL-CLEAR.
- 7. ALL FIXED WING AIRCRAFT WILL FLY FROM THE RUNWAY PILOT STATIONS AREA. ALL HELICOPTERS, DRONES AND QUADS WILL FLY ONLY LINE-OF-SIGHT FROM THE WEST AIRFIELD PILOTS AREA.

- 8. HELICOPTERS, DRONES AND QUADS MAY FLY LINE-OF-SIGHT FROM THE RUNWAY PILOT STATIONS AREA IF NO FIXED WING AIRCRAFT ARE PRESENT OR ALONGSIDE OTHER PILOTS WHEN AGREED UPON.
- 9. FPV AND VR PILOTS ARE REQUIRED TO HAVE A SPOTTER AND FLY ONLY LINE-OF-SIGHT.
- 10. NO MORE THAN 6 PILOTS IN THE AIR AT A TIME FROM THE RUNWAY PILOT STATIONS AREA. NO MORE THAN 4 PILOTS IN THE AIR AT A TIME FROM THE WEST AIRFIELD PILOTS AREA.
- 11. TAKEOFFS AND LANDINGS WILL BE INTO THE WIND TO ESTABLISH THE FLIGHT PATTERN, SUBSEQUENT PILOTS WILL FOLLOW THE SAME DIRECTION. FIXED WING AIRCRAFT MUST NOT FLY DIRECTLY OVER THE WEST HELI/DRONE/QUAD AIRFIELD.
- 12. THERE WILL BE NO FLYING OVER THE PITS AREAS, BEHIND THE PITS AREAS, BEYOND THE WEST TREELINE OR ABOVE THE GOLF COURSE TO THE NORTH.

***VIOLATION OF THE ABOVE FIELD RULES, (AFTER A VERBAL WARNING FOR THE FIRST OFFENSE) WILL RESULT IN THE PILOT GROUNDED FOR THE DAY.
